

# Legal Information for FAIR2Adapt

## Privacy Statement

FAIR2Adapt is committed to protecting your privacy and ensuring the security of your personal data. This Privacy Statement explains how we collect, use, store, and protect your information in compliance with the [General Data Protection Regulation \(GDPR\)](#).

## Data Collection and Processing

We collect and process personal data only to the extent necessary to provide and improve our services. This may include:

- Your **name, email address, and affiliation** when you contact us.
- **Technical data**, such as IP addresses, browser type, and interaction data, collected through cookies and analytics tools.

## Legal Basis for Processing

We process your personal data based on:

- **Your consent** (Article 6(1)(a) GDPR) when you submit a contact request.
- **Legitimate interest** (Article 6(1)(f) GDPR) in analyzing website traffic and improving user experience.
- **Legal obligations** (Article 6(1)(c) GDPR) where required.

## Purpose of Data Processing

Your personal data is processed for the following purposes:

- To **respond to inquiries** and provide user support.
- To **analyze website traffic** and improve user experience.
- To **comply with legal obligations** and enforce our Terms of Use.

## Data Retention

Your data will be retained for **a maximum of 4 years**, unless a longer retention period is required by law.

## Your Rights Under GDPR

You have the following rights regarding your personal data:

- **Access** – Request access to your personal data.
- **Correction** – Request correction of incorrect or incomplete data.
- **Erasure** – Request deletion of your data under certain circumstances.
- **Objection** – Object to data processing based on legitimate interests.

- **Portability** – Request transfer of your data to another service provider.
